MESSAGE FROM THE PRESIDENT

There really isn't much to talk about this month. But there are a few things I want to inform you about.

1. If you have done a transfer of property in Logan lowa, Logan is no longer sending out owners deeds back to you. You can request a copy from them, and they will send it to you at a small fee. If you haven't received a deed of transfer in your name and you have been waiting to receive it, you are not a member of the association.

We do have access to printing the deed in the office. From there we will be able to give you a copy, along with putting your name in our records so that the old owners will not be billed for the upcoming year's dues. If they receive them and you do not it will cause you to be keyed out because of non payment of dues. The transfer charge will be added to your dues. If you have not transferred your property in the office (not Logan) you will not be able to vote at the upcoming election nor will you be able to speak or make motions at the monthly meetings. You and your family cannot access the pool or club house. So please contact the office by means of calling or stopping in the office to see if you are in our records as a member. We are going through the records from the county and comparing them with ours. And, if you have not done a transfer you will be keyed out.

2. We have had numerous complaints about the lifeguards and numerous complaints about the adult swim time. Because of the complaints and badgering one lifeguard has quit. Because of the two separate complaints it has forced us to change the hours of the pool.

These lifeguards are young adults. Anywhere you go you very seldom will see adult lifeguards. They will only take so much and when we check things out from the complaints there is only half truths. They are not perfect, are you? If so go to a week's training and testing, and pay your \$150.00 to get your certification.

Adult swim time has always been broke up. We have put it together, 5-7 PM because of the shortage of lifeguards. Every pool around us is having problems. Check out **Onawa Aquatic Center** on face book or **Missouri Valley Aquatics Center.** Also check how many days they have been closed and blamed it on the weather??? Really? So the new hours of the pool is as follows;

12 to 7 PM with adult swim time 5 to 7 PM every day Sunday through Sunday. **No children in pool under the age of 18 at adult swim**. If we catch children under 18 in the pool at the adult swim with no lifeguard we will close it. And if we have no life guard at the pool it will be closed on the weekend. We are exempt Sunday at 3pm through Friday 3pm. This is a state law. We have an exempt certificate from the state beginning on Sunday thru Friday at 3 PM.

(Exempt code (641-15.4(5)"(4), IAC.)

Except holidays that fall on the weekend. Most pools are closing this month from August 9 through the 24 because lifeguards are returning back to school.

3. Next meeting on Sunday Sept. 13 is election of new Officers for the board. And changes of the bylaws. Most of the changes are just wording to make it easier to understand. The biggest change is the Sunday Annual meeting date, from Sunday to Saturday.

To summarize it

- 1. Annual meeting from 2nd Sunday to 2nd Saturday (page 5)
- 2. Voting to clarify how many votes you have.

(Page 3 and page 6)

3. Quorum to a number and not a percent.

(Page 5)

- 4. Number and Qualifications wife or husband. (Page 7)
- 5. Sending out Accounting Statements. We are only required to send out one a year at closing. (Page 10)

6. Cloths lines, Strike it out completely. It has no business in the bylaws. The bylaws are only for how we conduct meetings and the duties of our Board of Directors. Not rules. (Page 11).

ELECTION COMMITTEE

Volunteers are needed to serve on the Election Committee. The Election Committee is responsible to oversee all phases of the election process. Anyone interested in serving on the Election Committee should contact any Board member or leave their name with the Office Staff.

GENERAL INFORMATION

- 1. A list of candidates will be posted outside the Clubhouse.
- No campaigning or discussion of candidates outside the door of the voting area.
- Do not gather and talk inside the polling location; take it outside.
- 4. No more than two poll watchers allowed in the polling location at a time and must be approved by the Election Official. You will only be allowed in during the voting process. Anyone on the ballot, or family members, can not be poll watchers.
- The Election Committee consists of: One Election Official, one Assistant Election Official, three persons registering voters, one person at the ballot box, and twelve people counting ballots.
- 6. No campaign signs on trees. Campaign Signs are only allowed in designated areas. (If any candidate would like to put a campaign sign on a bulletin board, except at the Clubhouse, they need to drop them off at the office. PLEASE DO NOT TAPE ANY SIGNS ON THE BULLETIN BOARDS.)
- 7. It is suggested that if anyone

plans an event for a candidate it would be a good idea to invite all the candidates.

8. Write-ins are allowed.

ABSENTEE BALLOT INFORMATION

The following procedure <u>MUST</u> be followed and will be strictly monitored.

- You may obtain an absentee ballot from the office any day of the week during business hours. You must fill out a sheet for ballots and sign for the ballots.
- You may also obtain absentee ballots by writing the office at 1447 Benton Lane, Little Sioux, Ia., 51545. In your request you must <u>print</u> your name, mailing address, Block and Lot numbers, and sign your request. Requests without signatures will not be processed.
- Voters must be in good Standing and not owe the campground any money.
- Ballots that are mailed must be returned to Woodland Camp, 1447 Benton Lane, Little Sioux, lowa, 51545. The large envelope provided must be used for mail delivery.
- 5. The outer envelope <u>MUST</u> contain your name, Block, Lot numbers and signature. The small envelopes containing the ballots will be put in the ballot box to be opened and counted with the rest of the ballots. Any missing information will cause the ballot <u>NOT</u> to be counted.

ABSENTEE BALLOT INSTRUCTIONS

- 1. Please follow the instructions at the top of your ballot.
- Envelopes are marked respectively as
 "ENVIRONMENTAL ABSENTEE
 BALLOT", "BOARD OF DIRECTORS
 ABSENTEE BALLOT" and By-Laws
 ABSENTEE BALLOT.
- 3. Put your name, address, Block and Lot number (s) and

Signature in the return address corner of the large envelope.

Envelopes without signatures will not be counted.

- Put small envelopes inside large envelope addressed to Woodland Camp.
- Absentee ballots must be received in the office by close of business, (5:00 PM), Saturday, September 12, 2015.
- According to the BY-LAWS if you own one (1) lot you get one (1) ballot. If you own multiple lots you are entitled to two (2) ballots no matter how many lots you own.
- 7. On election morning, Sunday, September 13, 2015, the clerk responsible for your ballot will verify that you have voted by absentee ballot. They will open the envelope addressed to Woodland Camp and will place the absentee ballot envelope in the ballot box where it will be opened by the ballot counting committee; therefore, maintaining confidentiality of your vote. Ballots will not be accepted if not completed as instructed.
- Absentee ballots not received by close of business on September 12, 2015 by 5 PM will not be counted. You may not vote in person on Sept. 13, 2015 if you have requested an absentee ballot.

A REMINDER FOR YOUR SAFETY **GATE PRECAUTIONS!**

Please be aware of the following precautions when entering and leaving the campground.

Do not try to follow another vehicle through the gate, it will come down on your vehicle if you do not stop and use your key card.

Most of the time you will not need to use your key card when leaving. However, you still need to let the gate come down before you exit.

Towing vehicles with ropes or straps will also cause the gate to come down immaturely.

Pedestrians and bikers should not try to enter or exit the park without using a key card.

When letting someone in, or out, of the park DO NOT WALK UNDER THE GATE!

The gate may come down on you and could cause serious injury.

Please be advised that the park will not be responsible for any damage which results from any mis-use of the gate system.

TIP OF THE MONTH

Then, when you come back each week, that long hose connected to your camper, that has been setting in the sun, or buried in the baking ground for a week, is full of nasty, smelly water waiting to enter your water heater. One more reason you should;

- * Numbers, Flags, and Handicap stickers are available in the office for a small fee.
- * Remember, when you sell an off-road vehicle you need to remove your numbers from the vehicle.
- * * HINT: To remove the numbers from your vehicle you can use a hair dryer to heat the stickers and gently peel the stickers off.

It would be cheaper for us to put a fence around the south end of our property and not allow anyone except employees access to the burn pit area.




