



I want to thank everyone who was involved in the planning, preparation and serving of the Spaghetti Dinner and Ice Cream Social, the Silent Auction and the helping with the many activities last weekend for Ray's Benefit. We were amazed at the turnout and I was so glad that Kohll's Pharmacy donated the use of the wheelchair van so I could bring him up there. It did him a world of good to get out and see all of you!

This was only his 2nd outing since his stroke in December. He took it all in, even though he was tired and hot, (it had to be the most miserable day of the summer), he did not fall asleep on his trip back to Omaha. He was too busy looking out the windows!

Ray has a long road ahead of him but he has the love and determination to concur the effects of the stroke. His stroke was massive and he's paralyzed on the right side and the left side of his brain swelled into the good side, (right), of the brain, which left his vocal cords paralyzed. Therefore, he's not able to speak but an occasional whisper. I have gotten quite good at reading lips.

Because of this, he is fed with a feeding tube and just this past Wednesday, I worked with the speech therapist and I now will be able to feed him some pleasure foods, (pudding, applesauce and thicken juices), by teaspoon when I visit him. His first step in some real food after all these months.

Our medical insurance only covered 30 days of Skilled Nursing care and only 60 therapy sessions a year! Needless to say, that was taken care of long ago! Words can not express the gratitude and thoughtfulness of all of you to come out to help Ray.

ELECTION INFORMATION

A list of candidates will be posted outside the Clubhouse.

- No campaigning or discussion of candidates outside the door of the voting area.
- 3. Do not gather and talk inside the polling location: take it outside.
- 4. No more than two poll watchers allowed in the polling location at a time and must be approved by the Election Official. You will only be allowed in during the voting process. Anyone on the ballot, or family members, can not be poll watchers.
- The Election Committee consists of: One Election Official, one Assistant Election Official, three persons registering voters, one person at the ballot box, and eight people counting ballots.
- 6. No campaign signs on trees. Campaign Signs are only allowed in designated areas. (If any candidate would like to put a campaign sign on a bulletin board, except at the clubhouse, they need to drop them off at the office. PLEASE DO NOT TAPE ANY SIGNS ON THE BULLETIN BOARDS.)
- 7. All voters must be in good standing and not owe the campground any money.
- 8. It is suggested that if anyone plans an event for a candidate it would be a good idea to invite all the candidates.
- 9. Write-ins are allowed.

ABSENTEE BALLOT INFORMATION

Voting by absentee ballot will be handled slightly different than it has been in the past. The following procedure <u>MUST</u> be followed and will be strictly monitored.

In order to vote by absentee ballot you MUST make a request, in writing, to the office. The request MUST include the voters name, address, Block & Lot numbers and signed. All requests, which are complete, with the above information, will be forwarded to the Election Chair. The Election Chair will send the absentee ballots to the address which is on the request on the same day she receives the information from the office. (All ballots will be printed and distributed by the Election Chair.)

Note: No ballots will be handed out by the office!

Once you receive your absentee ballot read and follow the voting instructions which are included with the ballot.
(Example: If the ballot says to only vote for 3 candidates and you vote for 4 candidates the ballot will be considered spoiled and will not be counted. However, if you only vote for 2 candidates the ballot will be counted.)

After you have voted put the ballots in the small envelope and seal it. Make sure that you have printed your name, address, Block, and Lot numbers on the outside of the small envelope. Sign the small envelope and put it in the large, self addressed envelope, which was included with your ballots, and seal it. Make sure you have your return address on the outside of the large envelope.

All absentee ballots <u>MUST</u> be mailed to the PO Box which is on the large envelope which came with your ballots. All absentee ballots <u>MUST</u> be postmarked by Sept. 8th.

All absentee ballots will be picked up on Sept. 10th by the Election Chair and an Association member which is not related to a candidate.

The absentee ballots will be put in a locked ballot box and sealed with a numbered seal which will not be opened until the election day. (The number on the seal will be recorded and locked in the ballot box.) The ballot box will be opened by the Election Committee and the ballots will be counted with the rest of the ballots.

No absentee ballots will be handed out, or accepted, at the Election Chair's camper. (In the past the voters, who voted by absentee ballot, were allowed to drop the ballots off at the Election Chair's camper.)

All absentee ballots <u>MUST</u> be mailed to the PO Box on the envelope which accompanied your absentee ballots.
