Don't forget that Visa, Master Charge, and Discover credit cards are now accepted at the Woodland Camp Office.

Complaints:

Complaint forms may be obtained at the office. If you have a problem that needs to be resolved, and you would like the Board to resolve the problem, a complaint form must be completed and returned to the office in a sealed envelope. All information, including your full name, Block and Lot numbers, must be complete. All parties to which the complaint applies will be notified of when the complaint will be reviewed

will be reviewed.

FRIENDLY REMINDERS:

Here are some additional dates to remember:

April 1st Annual dues were due.

April 15th Your account was considered delinquent if not paid. Association members who are delinquent will be notified via certified mail at the property owner's expense.

April 30th Association members will be keyed out and utilities will be relinquished until dues are paid in full.

June 1st A fee of 10% of the total bill will be assessed to the owner's account. All fees and charges incurred will be assessed to the total amount owed.

Thereafter, on the first of each month, a fee of 10% of the total bill owed will be added to the delinquent account, and the owner will be notified via certified mail at the owner's expense until the account is paid in full.

Oct. 15th A lien will be levied on the owner's property and collection processes will be initiated at the owner's expense. Once the collection process has started, all fees incurred will be assessed to the responsible party or parties of the delinguent account.



Once a delinquent account has been brought up to date, and to protect Woodland Campground's employees, two of the four Executive Board Members, (President, Vice President, Secretary, or Treasurer), must sign off on the account prior to owner's privileges being re-instated.

Recipe of the Month

FLUFFY DUMPLINGS

1 cup sifted all-purpose flour 2 teaspoons baking powder 1/2 teaspoon salt * * * 1/2 cup milk 2 tablespoons salad oil

Sift flour, baking powder, and salt together into mixing bowl. Combine milk and salad oil; add all at once to dry ingredients, stirring just till moistened. Drop from tablespoon atop bubbling stew. Cover tightly; let mixture return to boiling. Reduce heat, (don't lift cover); simmer 12 to 15 minutes. Makes 10 dumplings.

will be considered null and void

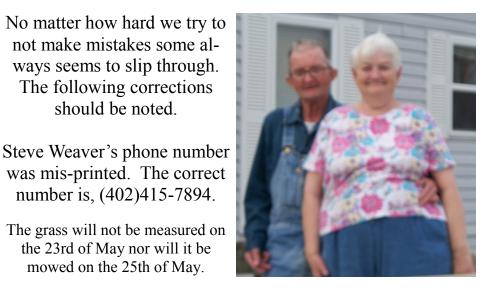

The Board of Directors would like to send a very special *THANK YOU* to someone who has been a **BIG** asset to this Association! Over the past few years she has worked many hours on her own time. She has never asked for anything in return nor has she received any compensation for what she does.

When she started negotiating the collection of dues which were over 2 years past due, there was over \$ 251,000.00 in dues and fees owed. She presents herself in a VERY professional manner and has been successful in either collecting fees owed or getting the property owner to surrender their deed to Woodland Campground. As of the writing of this letter there is two association members in errors and just over \$4,000.00 of dues over 2 years past due.

One example of how the funds were used is to purchase of our new Office and living quarters for our winter employees. Another example of the results of her work is that we have been able to stay in the black financially.

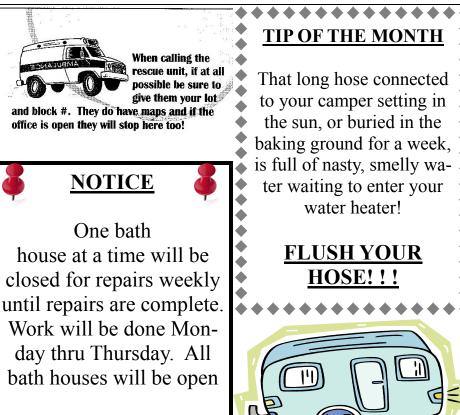
